He therefore offers a general reflection on the conditions of French middle classes in the context of the economic crisis.

In this book, the author makes a vivid portrait of the middle classes from a comparative perspective. After having shown how different they can be in size, according to their definition, he discusses three dominant theses on French middle classes – their disadvantage deriving from the socio-fiscal system, their déclassement, and their relegation to peri-urban areas – and concludes that the crisis has not significantly affected their conditions, whereas American middle classes are experiencing a démoyennization. On the other hand, emerging middle classes in developing countries are growing in importance.
